**SUMMARY/BACKGROUND:** On or before July 15<sup>th</sup>, the District Treasurer submits to the District Board a proposed budget for the new fiscal year. The proposed budget includes statements and estimates of the operation and maintenance expenses of the District, the costs of capital improvements to be financed by bond proceeds repaid through special assessments against benefited property in the District, and the amount of all other expenditures (i.e. trustee fees, audit fees, etc.) for municipal services. On May 2, 2013, the District Board met to discuss and review the proposed budget. The Treasurer has submitted the budget for Fiscal Year 2013-14 and has filed the necessary statements and estimates.

If the District Board approves this Tentative Budget for Fiscal Year 2013-14 by adoption of Resolution No. 26 the attached notice will be published giving notice of a public hearing on July 11, 2013 to receive comment on the Tentative Budget.

After the public hearing, the District Board may adopt a Final Budget by resolution.
