

## **RESOLUTION NO. 1870**

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PRESCOTT VALLEY, A MUNICIPAL CORPORATION OF ARIZONA, AUTHORIZING THE SUBMISSION OF ONE OR MORE APPLICATIONS FOR FEDERAL GRANT FUNDS (WHICH MAY INCLUDE FEDERAL FUNDING THROUGH THE DEPARTMENT OF HOMELAND SECURITY/FEMA ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM, FIRE PREVENTION & SAFETY GRANT); CERTIFYING THAT ANY SUCH APPLICATIONS ENHANCE THE HEALTH AND SAFETY OF THE COMMUNITY AND FULFILL THE REQUIREMENTS OF THE DEPARTMENT OF HOMELAND SECURITY/FEMA; AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATIONS; AND PROVIDING THAT THIS RESOLUTION SHALL BE EFFECTIVE AFTER ITS PASSAGE AND APPROVAL ACCORDING TO LAW.

WHEREAS, the Mayor and Common Council of the Town of Prescott Valley desires to update the Town's technological systems to improve communication and collaboration with various departments and regional partners and provide the various departments and regional partners with data for analysis; and

WHEREAS, the Department of Homeland Security/FEMA is administering the Assistance to Firefighters Grant Program; and

WHEREAS, the activity in this proposed application will address the community's technological needs associated with public health and safety, land management and asset management needs; and

WHEREAS, a recipient of federal grant funds is required to comply with state and federal statutes and regulations;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PRESCOTT VALLEY, ARIZONA, AS FOLLOWS:

1. Appropriate Town staff is hereby authorized to make application for federal grant funds through the Department of Homeland Security/FEMA Assistance to Firefighters Grant Program, Fire Prevention & Safety Grant, and Mayor Harvey C. Skoog (or, in his absence, the Vice Mayor) is hereby authorized to sign the application and any related contract or grant documents for receipt and use of these funds. Furthermore, all other actions necessary to implement and complete the activities outlined in any such applications are hereby authorized (and specifically Carmen Ogden, Planner (or her designee or replacement) is hereby authorized to take all actions necessary to implement and complete the activities submitted in said applications.

2. It is hereby certified that any such applications will enhance the health and safety of the community and fulfill the requirements of the Department of Homeland Security/FEMA. To that effect, the Town of Prescott Valley will comply with all policies, state and federal

statutes and regulations applicable to the Assistance to Firefighters Grant Program and will fulfill all the requirements of the Department of Homeland Security/FEMA.

3. This Resolution shall be effective after its passage and approval according to law.
