SUMMARY BACKGROUND: The Town of Prescott Valley (Town) is a founding member and fiscal agent of the Upper Verde River Watershed Protection Coalition (Coalition). Created in June, 2006, the Coalition's objective includes protecting the base flow of the Upper Verde River to the maximum extent possible and reaching Safe Yield in the Prescott Active Management Area. The Coalition wishes to leverage its budget, derived through membership dues, by applying for grants to fund Coalition projects. The Coalition would like to apply for grants from Title II Resource Advisory Committee (up to \$75,000), US Bureau of Reclamation Landscape Conservation Cooperative (up to \$100,000), US Department of Agriculture Wood Education and Resource Center, Wood Energy Teams and Wood To Energy (2 grants, up to \$250,000 each), Coca Cola Foundation (up to \$100,000), Hewlitt Foundation (up to \$100,000), and Lowe's Foundation (up to \$10,000).

As fiscal agent for the Coalition, the Town will be responsible for administering the grants. The Town Council must give approval before the Coalition can pursue these grants.

PREVIOUS ACTIONS: On several occasions, the Town Council approved the Coalition moving forward on a number of grant applications. On June 8, 2006, the Town Council entered into an Intergovernmental Agreement with Yavapai County, the City of Prescott, the Town of Chino Valley and the Town of Dewey-Humboldt to create the Upper Verde River Watershed Protection Coalition.

On February 22, 2007, the Town Council approved membership contributions for the Coalition for \$55,000 per year.

OPTION ANALYSIS: The Council may vote to:

- 1.) approve this proposal, **OR**
- 2.) not approve this proposal, **AND/OR**
- 3.) direct staff to pursue other options.

ACTION OPTION: Consent approval for the Coalition's proposal to pursue the Title II Resource Advisory Committee, US Bureau of Reclamation Landscape Conservation Cooperative, US Department of Agriculture Wood Education and Resource Center, Wood Energy Teams and Wood To Energy, Coca Cola Foundation, Hewlitt Foundation, and Lowe's Foundation grants. **VOTE**

RECOMMENDATION: Town staff recommends approval of this proposal to pursue the grants listed.

FISCAL ANALYSIS: If the Coalition obtains grant funding, the Town will administer the funds according to requirements of the grant.
