**SUMMARY BACKGROUND:** ARS 9-236 authorizes town councils to appoint persons to act in the place of the mayor when the mayor is absent. Based on that authority, Prescott Valley Town Code 2-02-020 says the Council shall designate one of its members to be Vice Mayor at the same regularly-scheduled meeting where the Mayor assumes office. In between, the Vice Mayor serves at the pleasure of the Council. The role of the Vice Mayor is to perform the duties of Mayor in the "absence or disability of the Mayor". If both the Mayor and Vice Mayor are absent or disabled, then the Council may designate another member to be Acting Mayor for that period of time. [Town Code 2-02-030]

Beginning in 2007, the Council began a practice of selecting a new Vice Mayor each year. Since the Mayor has previously assumed office at the first regular Council meeting in June every four years, the selection of a Vice Mayor has been scheduled each year at the first regular meeting in June. In an effort to encourage unanimity, the Council has settled on a process of first holding an informal paper ballot to determine the top vote-getter, followed by a formal roll call or electronic vote. Historically, the top vote-getter has then been nominated and the vote in favor has been unanimous. Using this procedure, the following Council members have been selected as Vice Mayor:

2007-2008 Council member Harold Wise  
2008-2009 Council member Fran Schumacher  
2009-2010 Council member Lora Lee Nye  
2010-2011 Council member Rick Anderson  
2011-2012 Council member Patty Lasker  
2012-2013 Council member Don Tjiema  
2013-2014 Council member Lora Lee Nye  
2014-2015 Council member Lora Lee Nye

Last week in the work-study meeting, the Council conducted an informal paper ballot which resulted in the top vote-getter for the position of Vice Mayor in 2015-2016 being Council member Rick Anderson. It is now proposed that Council member Rick Anderson be formally voted in as Vice Mayor.

**OPTION ANALYSIS:** Council members may vote to ratify the selection of the top vote-getter in the informal paper ballot for 2015-2016 Vice Mayor, Or may vote to select another Council member as Vice Mayor. In either case, the person selected as Vice Mayor shall serve going forward at the pleasure of the Council.

**ACTION OPTION:** Motion to appoint Council member Rick Anderson as Vice Mayor to serve at the pleasure of the Council. **VOTE.**
