

RESOLUTION NO. 1959

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PRESCOTT VALLEY, A MUNICIPAL CORPORATION OF ARIZONA, AUTHORIZING THE SUBMISSION OF AN APPLICATION(S) FOR FEDERAL GRANT FUNDS (WHICH INCLUDE FEDERAL FUNDING THROUGH THE DEPARTMENT OF HOMELAND SECURITY/FEMA ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM, FIRE PREVENTION & SAFETY GRANT), CERTIFYING THAT THE APPLICATION(S) ENHANCES THE HEALTH AND SAFETY OF THE COMMUNITY AND FULFILLS THE REQUIREMENTS OF THE DEPARTMENT OF HOMELAND SECURITY/FEMA; AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATION.

WHEREAS, the Mayor and Common Council of the Town of Prescott Valley desires to update the Town's technological systems to improve communication and collaboration with various departments and regional partners and provide the various departments and regional partners with data for analysis ; and

WHEREAS, the Department of Homeland Security/FEMA is administering the Assistance to Firefighters grant program; and

WHEREAS, the activity in the proposed application will address the community's technological needs associated with public health and safety, land management and asset management needs; and

WHEREAS, a recipient of Federal Grant Funds is required to comply with State and Federal Statutes and regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PRESCOTT VALLEY, ARIZONA, authorize application to be made for federal grant funds through the Department of Homeland Security/FEMA Assistance to Firefighters grant program, Fire Prevention & Safety Grant and authorize Harvey Skoog, Mayor, to sign the application or contract or grant documents for receipt and use of these funds, and authorize Carmen Ogden, Planner, to take all actions necessary to implement and complete the activities submitted in said application(s); and

THAT, the MAYOR AND COMMON COUNCIL OF THE TOWN OF PRESCOTT VALLEY, ARIZONA, will comply with all Policies, State and Federal Statutes and regulations applicable to the Assistance to Firefighters grant program and will fulfill all the requirements of the Department of Homeland Security/FEMA; and

This Resolution shall be effective after its passage and approval according to law.
