

Our firm represents Hall Inc. d/b/a Prescott Golf & Country Club ("PGCC") which holds liquor license #06130032 issued at its real property located at 1030 Prescott Country Club Blvd in Dewey, AZ. Within the series 6 licensed premises is a restaurant that Hall Inc. intends to lease to 4Koltrev LLC, beginning on July 13, 2014.

4Koltrev LLC (Kevin Leffler, Agent) submitted a series 12 liquor license application for the restaurant only on or about April 7, 2014 under the business name Bogeys Grill. We have been informed that the series 12 license (#12133585) is now ready for issuance.

Concurrent with the *issuance* of the series 12 license, PGCC, as landlord and holder of the series 6 license, requests that the premises for the series 6 license be modified to delete the area encompassing the restaurant only. Please consider this letter as authorization to delete the restaurant location from the series 6 premises upon *issuance* of license #12133585, but no sooner than July 13, 2014. Until license #12133585 is issued, the premises for license #06130032 is to remain unchanged. Please refer to the enclosed Exhibits "A" and "B" for the licensed premises for each license.


