

SUMMARY BACKGROUND: The Town enjoys a successful relationship with the Yavapai County Flood Control District (YCFCD) to fund storm water management studies and construction projects with the countywide tax levy collected by YCFCD. The Town makes recommendations on a yearly basis for projects and enters into Intergovernmental Agreements (IGA) to fund projects which are administered by the Town and reimbursed by YCFCD.

For this FY 2016/17 budget year, the Town has been approved for \$500,000 to design and/or construct various flood control improvement projects to include construction of Phase 2 of the Viewpoint Dr. Floodplain Channelization project from Manley Dr. to Spouse Dr., construction of drainage improvements for the PV Pipeline Multi-Use Path project, drainage design for Sunset Lane Roadway Improvements project, and outreach for the Town’s FEMA re-mapping efforts.



OPTION ANALYSIS: The Council may vote to:

- 1.) Approve the Intergovernmental Agreement, **OR**
- 2.) Not approve the Intergovernmental Agreement, **AND/OR**
- 3.) Direct staff to pursue other options

ACTION OPTION: Motion to approve the Intergovernmental Agreement for the Viewpoint Floodplain Channelization project, **OR** not approve the Intergovernmental Agreement. **VOTE.**

RECOMMENDATION: Staff recommends approval of the Intergovernmental Agreement for a total funding amount of \$500,000 which would provide 100% of the funds necessary for the design and/or construction of the projects listed in the IGA.

FISCAL ANALYSIS: The total cost of this project is funded from a grant through the Yavapai County Flood Control District.
