**SUMMARY/BACKGROUND:** The Governor’s Office of Highway Safety (GOHS) recently solicited grant proposals to enhance underage drinking enforcement programs throughout Arizona for the 2010 Federal Fiscal Year. Through Council’s approval, the Prescott Valley Police Department (PVPD) submitted an application to receive funding for a program which focuses on preventing and taking enforcement action on underage drinking violations throughout Prescott Valley. In November 2009, the department received partial funding from GOHS in the amount of \$2,500.

On March 23, 2010, PVPD received notification from GOHS of an additional grant award providing funds for personnel services (overtime) and employee related expenses in the amount of \$10,000. Funds will be utilized for the purpose of conducting underage drinking prevention and enforcement activities which will greatly enhance PVPD’s efforts in maintaining a pro-active approach to these issues. Efforts include a public education and awareness campaign; the “Every Fifteen Minutes” program; party patrols; and various other enforcement details related to enforcing underage drinking laws.

Acceptance of the Highway Safety Contract requires a certified Council Resolution authorizing entry into the contract with GOHS.

**OPTIONS ANALYSIS:** Council may either accept the GOHS 2009 Underage Alcohol Enforcement Grant Award (Contract # 2010-OJJDP-013) through Resolution No. 1697 **or** decline to adopt the resolution.

**ACTION OPTION:** Motion to authorize the Mayor (or, in his absence, the Vice Mayor) to sign Resolution No. 1697 accepting the GOHS 2009 Underage Alcohol Enforcement Grant Award (Contract # 2010-OJJDP-013). **VOTE.**

**RECOMMENDATION:** Staff recommends authorizing signature of Resolution No. 1697 accepting the grant award.

---

**FISCAL ANALYSIS:** There is no fiscal impact to the Town. This grant is fully reimbursable through the Governor’s Office of Highway Safety.
