SUMMARY/BACKGROUND: On April 25, 2010, four terms came up for renewal on the Personnel Board: Jan Bear-Non-Exempt Alternate, Judy Stanley-Non-Exempt, Louise Teague-Curtis-Citizen, and Evelyn Larriba-Citizen Alternate.

Jan Bear was appointed to her first term as the non-exempt alternate employee member on the Personnel Board in May 2004 and this re-appointment will be her 4th consecutive term. Judy Stanley was appointed to her first term as the non-exempt alternate employee member in May 2004 and this re-appointment will be her 4th consecutive term in this position. Louise Teague-Curtis was appointed to her first term as a citizen member in January 2007 and this re-appointment will be her 3rd consecutive term. Evelyn Larriba was appointed to her first term as the citizen alternate member in June 2008 and this re-appointment will be her 2nd consecutive term.

Jan Bear, Judy Stanley, Louise Teague-Curtis and Evelyn Larriba all submitted a renewal letter application to be reappointed. Vice-Mayor Flannery, Council member Schumacher and Council member Nye are recommending the re-appointment of Jan Bear as non-exempt alternate employee member, Judy Stanley as non-exempt employee member, Louise Teague-Curtis as citizen member and Evelyn Larriba as citizen alternate member with all four terms ending April 25, 2012.

OPTIONS ANALYSIS: The Council may authorize the re-appointments of Jan Bear, Judy Stanley, Louise Teague-Curtis and Evelyn Larriba to the Personnel Board or re-advertise one or more of the positions for additional candidates.

ACTION OPTION: Motion to re-appoint Jan Bear as non-exempt alternate employee member, Judy Stanley as non-exempt employee member, Louise Teague-Curtis as citizen member and Evelyn Larriba as citizen alternate member with all four terms ending April 25, 2012. **OR** Motion to table this appointment.
