**SUMMARY/BACKGROUND:** On or before July 15<sup>th</sup>, the District Treasurer submits to the District Board a proposed budget for the new fiscal year. The proposed budget includes statements and estimates of expenses of the District to be repaid through special assessments against property owners within the District, and the amount of all other operation expenditures to be paid from the assessment bond revenues and other sources. On May 6, 2010, the District Board met to discuss and review the proposed budget. The Treasurer has submitted the budget for Fiscal Year 2010-11 and has filed the necessary statements and estimates.

If the District Board approves this Tentative Budget for Fiscal Year 2010-11 by adoption of Resolution No. 14, the attached notice will be published giving notice of a public hearing on June 24, 2010 to receive comment on the Tentative Budget.

After the public hearing, the District Board may adopt a Final Budget by resolution.
