**SUMMARY/BACKGROUND:** On June 30, 2010, three terms come up for renewal on the Parks and Recreation Commission; Jeff Spohn, Donald Rollins & Ron Brinkman. All submitted the renewal application letters to be reappointed.

Jeff Spohn was appointed to his first term on the Parks and Recreation Commission in February 2006 to replace Mike Kenny who was removed by council action in February 2004. This re-appointment will be Jeff Spohn's 3<sup>rd</sup> consecutive term. Donald Rollins was first appointed to a partial term in August 2007 to replace John DeBroske who resigned. This reappointment will be Donald Rollins 2<sup>nd</sup> consecutive term. Ron Brinkman was first appointed to a partial term in July 2009 to replace David Skopec who resigned.

Vice-Mayor Lora Lee Nye, Council member Flannery and Council member Schumacher are recommending the re-appointment of Jeff Spohn, Donald Rollins and Ron Brinkman to terms with a renewal date of June 30, 2013.
