**SUMMARY/BACKGROUND:** On October 31, 2010, three terms come up for renewal on the Planning and Zoning Commission; Rick Duskey, Nicole Russell and John Gay. All submitted the renewal application letters to be reappointed.

Rick Duskey was appointed to his first partial term on the Planning and Zoning Commission in June 2008 to replace Leslie Wayman who resigned. This re-appointment will be Rick Duskey's 2<sup>nd</sup> consecutive term. Nicole Russell was first appointed to a partial term in December 2009 to replace Gary Bruce who resigned. This reappointment will be Nicole Russell's 2<sup>nd</sup> consecutive term. John Gay was first appointed to a partial term in June 2010 to replace Larry Parkhurst who resigned. This reappointment will be John Gay's 2<sup>nd</sup> consecutive term.

Councilmember Flannery, Councilmember Nye and Councilmember Lasker are recommending the re-appointment of Rick Duskey, Nicole Russell and John Gay to terms with a renewal date of October 31, 2013.
