**SUMMARY/BACKGROUND:** The Governor’s Office of Highway Safety (GOHS) recently solicited grant proposals to enhance underage drinking enforcement programs throughout Arizona for the 2011 Federal Fiscal Year. Through Council’s approval, the Prescott Valley Police Department (PVPD) submitted an application to receive funding for a program which focuses on preventing and taking enforcement action on underage drinking violations throughout Prescott Valley.

On November 1, 2010, PVPD received notification from GOHS of a Federal Department of Justice grant award providing funds in the amount of \$13,525. The funds will be utilized for the purpose of conducting underage drinking prevention and enforcement activities through a public education and awareness campaign. Activities include the “Every Fifteen Minutes” program, party patrols, Covert Underage Buying (CUB) details, distribution of “Draw the Line” pizza box fliers, and various other advertisement and enforcement details related to enforcing underage drinking laws.

Acceptance of the Highway Safety Contract requires a certified Council Resolution authorizing entry into the contract with GOHS.

**OPTIONS ANALYSIS:** Council may either accept the GOHS 2011 Underage Alcohol Enforcement and Education Grant Award – Contract # 2011-DOJ-008 (2010) through Resolution No. 1727 **or** decline to adopt the resolution.

**ACTION OPTION:** Motion to authorize the Mayor (or, in his absence, the Vice Mayor) to sign Resolution No. 1727 accepting the GOHS 2011 Underage Alcohol Enforcement and Education Grant Award – Contract # 2011-DOJ-008 (2010), **OR** Motion not to accept the GOHS Grant Award. **VOTE.**

**RECOMMENDATION:** Staff recommends authorizing signature of Resolution No. 1727 accepting the grant award.
