SUMMARY/BACKGROUND: Three (3) positions on the Arts and Culture Commission became open when Susan Stewart resigned in May 2010, Suzanne Applegate resigned in June 2010 and appointed to the Parks and Recreation Commission, and Richard Patton resigned in July 2010. Susan Stewart was appointed to the Arts and Culture Commission on September 24, 2009 to a full term with a renewal date of June 30, 2012. Suzanne Applegate was appointed on February 11, 2010 to an existing position with a term renewal date of June 30, 2010. Richard Patton was appointed on January 14, 2010 to an existing position with a term renewal date of June 30, 2011.

The vacancies were advertised and five (5) applications were submitted. Councilmember's Mike Flannery, Lora Lee Nye and Patty Lasker conducted the interviews and are recommending the appointment of Carol Power to fill the partial term made open by the resignation of Richard Patton with a renewal date of June 30, 2011, appointment of Franki Gibson to fill the partial term made open by the resignation of Susan Stewart with a renewal date of June 30, 2012, and the appointment of Charley Ables to fill the full term made open by the resignation of Suzanne Applegate with a renewal date of June 30, 2013.

OPTIONS ANALYSIS: The Council may authorize the appointment of Carol Power, Franki Gibson and Charley Ables to the Arts and Culture Commission or advertise the position(s) for additional candidates.

ACTION OPTION: Motion to appoint Carol Power to fill an existing term with a renewal date of June 30, 2011, Franki Gibson to fill an existing term with a renewal date of June 30, 2012 and Charley Ables to fill a full term with a renewal date of June 30, 2013 **OR** Motion to table any or all of the appointments.
VOTE.

RECOMMENDATION: The Council members involved in this selection process recommend approval of the appointments of Carol Power, Franki Gibson and Charley Ables to the Arts and Culture Commission.
