The Town of Prescott Valley is seeking bids for the following Portable Toilet Services over a 12-month period starting July 1, 2011 and ending June 30, 2012.

The Town utilizes the services of a portable toilet vendor for special events. In addition, several of the Town's Parks use portable toilets in the winter in lieu of the main restrooms at the parks. Other toilets are used on an 'as-needed' basis. Standard service is once per week. Monthly charges for long term rentals must include all charges for cleaning and pumping of unit. Bid item number five (5) will only be recognized when additional services beyond once a week are authorized by Town employees.

The bid schedule below is only an estimate of the anticipated requests for service and will vary throughout the year:

1. Special events
Per toilet, per event: \$ 40.00
2. Handicapped accessible toilet
Per event: \$ 40.00
3. Single toilet
Per week: \$ 5.00
4. Winter Park toilets (approximately 6 to 10 units)
These units must be handicap accessible
Per toilet, per month: \$ 33.00
5. Extra service
Per toilet: \$ 1.00
