

SUMMARY BACKGROUND: Fiscal Year 2011/12 Town budget includes a capital project to add a mile long connector road to join the two existing Viewpoint Drives between Manley Dr. and Roundup Dr. With the recent Robert Road improvements complete, the Town can now proceed with the design of the Viewpoint Drive Connector.

This Project is funded by the third cent sales tax for roadway improvements as recommended in the 2002 Street Committee Report. This action is for the consideration of approval of an Amendment to the Town Engineer Agreement with Dava & Associates, Inc. for design services in an amount not to exceed \$274,300.00.

Council is also asked to consider approval of a budget transfer needed to cover the design cost. This transfer will be within the third cent sales tax account and come from the allocated funds to the Navajo project. The balance needed to complete design will be spent in FY12/13 under the third cent sales tax revenue budgeted at \$2,100,000.00
